

PHOBI AURODIL SUPER PB+

EMULSIFIABLE LIQUID CONCENTRATE
USED AGAINST FLYING AND CRAWLING INSECTS

PROFESSIONAL USE

Composition

Permethrin (CAS Number 52645-53-1): 250 g/L
Piperonyl butoxide (CAS Number 51-03-6): 150 g/L
D-trans-Allethrin (CAS Number 260359-57-7): 20 g/L

Indications

PHOBI AURODIL SUPER PB+ is used to fight against crawling and flying insects such as ants, cockroaches, darkling beetles, flies, mosquitoes, stored products moths (*Sitophilus oryzae*, *Tribolium confusum*, *Ephesia kuehniella*), mites (acarina), bedbugs, fleas, in houses, offices, hotels, restaurants, baker's shops, kitchens, warehouses...

D-allethrin and permethrin are pyrethroids that disturb nervous systems of flying and crawling insects. These two molecules confer to **PHOBI AURODIL SUPER PB+** a "knock-down" effect and the treated surfaces are protected during several weeks.

Strengths

- Flushing action.
- Shock and long-lasting effect.
- Odorless after dilution.

Instructions for use

PHOBI AURODIL SUPER PB+ is an insecticide preparation to be diluted in water before use:

- 50 mL in 5 L of water for maintenance treatment.
- 100 mL in 5 L of water for shock treatment.

Surface treatment:

1 L of mixture to spray 100 linear meters or 10 to 20 m².
Ventilate during the treatment and thoroughly air out the treated area before reoccupying (30 minutes to 2 hours depending on ventilation level).

Volume treatment (hot or cold fogging):

Indoor treatment: 1 L of mixture for 1000 m³.

Outdoor treatment: 1 L of mixture for 0.5 to 1 hectare against flying insects.

Evacuate animals, cover aquariums (turn off the pump) and terrariums before fogging. Keep the area closed for 4 to 6 hours for optimal effectiveness.

Thoroughly air out the area before reoccupying.



Packaging

500 ml dosing bottle

Storage and disposal

Store at a temperature above 5°C.

Keep unused product in its original packaging.

Store out of reach of children and away from human and animal food. Store in a ventilated area and keep away from heat sources. Do not reuse the packaging. Do not dispose of residues in sewers or waterways. Packaging and product must be disposed of as hazardous waste under the full responsibility of the holder of such waste.

Safety instructions

PT18 - Use biocides safely. Always read the label and product information before use. Dangerous. Follow safety instructions.

Always test surface tolerance before treatment with a preliminary test in a hidden corner. Pay special attention to sensitive surfaces (paint, varnish, fabrics, waxed parquet floors, etc.). For use on industrial food processing and manufacturing chains, hermetically cover all installations. After treatment, rinse all surfaces that come into contact with food products.

Do not use on cats or pet baskets for cats. **Keep cats away from treated surfaces.** This biocidal product contains pyrethroid active substance name which can cause severe adverse reactions in cats. If pets have exposure, get veterinary advice attention.
