PROFESSIONAL USE

Composition

Cypermethrin (CAS Number 52315-07-8): 100 g/L **Prallethrin** (CAS Number 23031-36-9): 5 g/L

Indications

Micro-encapsulated insecticide against crawling and flying insects such as cockroaches, bed bugs, ants, flies, and mosquitoes. Prallethrin provides shock action with a significant knockdown effect. The microencapsulation of cypermethrin ensures the stability of the substance against light, temperature, and humidity. Thanks to the different capsule sizes, the release of cypermethrin is regular and continuous.

Mode of action

Shock effect and long-lasting action. After treatment, the treated surface is covered with thousands of microcapsules.

PHOBI CYPRABIO CAPS acts in less than 15 minutes and protects treated surfaces for up to 12 weeks.

Re-treat only in case of a new infestation.

Strengths

- Shock effect & long-lasting action.
- Odorless and non-staining.
- Effective on porous and non-porous surfaces.

Instructions for use

Shake the bottle well before use to homogenize the microcapsules in the bottle. Dilute the product at a rate of 50 mL in 5 L of water for 100 m^2 .

To preserve the capsules, remove the filters present in the nozzle and use a sprayer with a maximum pressure of 3 bars.

Evacuate personnel from the treated area. Spray areas frequented by insects, especially light-colored surfaces. Allow the product to act before re-entering the area. Spray while moving backward, distributing the product evenly. It is unnecessary to soak the surfaces: a light, evenly distributed film is sufficient.

<u>Special case for wasps and hornets:</u> spray on the nest in concentric circles from the periphery to the center. As a purely indicative measure, approximately 1 L is needed to treat a medium-sized nest.

The quality of the treatment is as important as the quality of the product. The use of a professional sprayer with an anti-drip lance is strongly recommended.

LODI advice: rinse the sprayer thoroughly after use with clear water.







Packaging

500 ml dosing bottle

Storage and disposal
