PROFESSIONAL USE

Indications

PHOBI CONTACT+ is a new-generation concentrated liquid insecticide. It can be sprayed directly on insects or used to target surfaces where they may hide.

PHOBI CONTACT+ is made for indoor use and around buildings/ homes to fight a broad spectrum of crawling insects: bed bugs, cockroaches, ants, house spiders, centipedes. The patented formula of this new-generation insecticide makes it amazingly effective, even on porous surfaces, with a very long-lasting effect of 3 months.

Composition

Cypermethrin (CAS Number 52315-07-8) : 25 g/L **Geraniol** (CAS Number 106-24-1) : 0,1 g/L

Strengths

- 100% effective.
- Long-lasting action: 3 months.
- No smells or stains.

Instructions for use

Before use, shake the bottle to homogenize the product.

Dilute the product depending the infestation:

- 100 ml in 5 L of water in case of low infestation.
- 200 ml in 5 L of water in case of heavy infestation.

Once diluted, apply the product at a dose of 50 ml/m².

PHOBI CONTACT+ is designed for use in and around homes: kitchens, bedrooms, garages, cellars, attics... and can also be used in restaurants, industrial premises, hospitals, food industry premises. Apply in spots or in cracks and crevices where target insect activity is visible.

PHOBI CONTACT+ can be sprayed directly on insects or used to target surfaces where they may hide:

- Bed bugs: baseboards and bed base slats.
- Cockroaches, ants, spiders: beneath sinks and refrigerators, kitchen units, etc.

For indoor use, the product should only be applied to restricted areas, not regularly cleaned. Surfaces should not be cleaned during the treatment period (up to 3 months).

Disposal

Do not dispose of the biocide in drains (sinks, toilets, etc.), gutters, watercourses, fields or any other outdoor environment. Dispose of unused product, its packaging and any other waste in an appropriate collection facility.

Safety instructions

PT18 - Use biocides safely. Always read the label and product information before use. Dangerous. Follow safety instructions.

For outdoor use, do not apply to vegetable gardens or absorbent soil.

For indoor use, ventilate during the treatment and before reoccupying the premises (30 minutes to 2 hours, depending on the ventilation level). Clean the equipment after use. Wear gloves and wash your hands after use.

Do not spray on/towards humans and animals.

Cover or remove food, dishes, aquariums, terrariums and cages. Turn off power to aquarium pumps before spraying. Do not use on cats or pet baskets for cats. **Keep cats away**

from treated surfaces. This biocidal product contains pyrethroid active substance name which can cause severe adverse reactions in cats. If pets have exposure, get veterinary advice attention.
