

LIQUID CONCENTRATE INSECTICIDE FOR TREATMENT OF LIVESTOCK BUILDINGS

PROFESSIONAL USE

Composition

Chrysanthemum cinerariaefolium extract from open and mature flowers of Tanacetum cinerariifolium obtained with supercritical carbon dioxide (**Pyrethrum**) 20 g/L PBO-Free formula.

Indications

ORION is an emulsifiable liquid concentrate insecticide for use against crawling and flying insects. The product can be used in livestock buildings of cattle, sheep, goat, swine, poultry and rabbit farms, against flies, midges, litter beetles (darkling beetles), red mites, cockroaches...

Strengths

- Shock action.
- Can be used in organic farming*
- Can be used in the presence of animals**.

*Product suitable for use in organic farming in accordance with Regulation (EC) 2018/848, for elimination of insects and other pests in buildings and other facilities where animals are kept

Instructions for use

Shake before use. Wear protective equipment appropriate for the treatment being used.

Surface treatment: spray on all surfaces of the area to be treated, including walls and ceilings.

<u>Low infestation</u>; dilute 250 ml of concentrate in 5 L of water for 100 m² or 1 L in 20 L of water for 400 m². Spray with a suitable sprayer. <u>Heavy infestation</u>; double the dose.

Volume treatment: apply 200 ml to 400 ml of undiluted product with a cold fogger to treat 1000 m³.

Variable ventilation time depending on the ventilation level and the size of the area to be treated (30 minutes to 2 hours).

The product can be applied in the presence of animals, but avoid direct contact with them during application.

Do not spray on waterers, feeders, or other items intended to receive food.





Packaging

Disposal

Do not reuse the packaging. Do not dispose of residues in sewers or waterways. Packaging and product must be disposed of as hazardous waste under the full responsibility of the holder of such waste.

Safety instructions

PT18 - Use biocides safely. Always read the label and product information before use. Dangerous. Follow safety instructions.

Repeat treatment in case of new infestation.

Clean equipment thoroughly after use.

It is recommended to wear gloves and wash your hands after each use. Rinse food contact surfaces thoroughly after each use. Take all appropriate measures to prevent contamination of packaged food.

Keep cats away from treated surfaces. This biocidal product contains pyrethroid active substance name which can cause severe adverse reactions in cats. If pets have exposure, get veterinary advice attention.

^{**}Avoid direct contact with animals during application.
