Composition

D-Tetramethrin (CAS Number 1166-46-7): 1,5 g/L **Cypermethrin** (CAS Number 52315-07-8): 5 g/L

Indications

D-Tetramethrin is the active form of Tetramethrin, a highly volatile molecule that gives **PHOBI FLYING AND CRAWLING INSECTS** a shock action.

Cypermethrin combines this KD effect with a powerful immediate lethal effect (Killing effect) and long-lasting action.

PHOBI FLYING AND CRAWLING INSECTS is indicated for treatments against flying insects as it immediately knocks down insects in flight, and for treatments against crawling insects due to its knockdown effect on treated surfaces.

Formulated exclusively with pyrethroids, it is particularly recommended for interventions requiring the total absence of organophosphates.

Strengths

- Powerful shock effect.
- Strong long-lasting action.
- Odorless.

Instructions for use

Evacuate personnel from the treated area.

Spray areas frequented by insects, especially light-colored surfaces. Allow the product to act before re-entering the area.

Spray while retreating, distributing the product evenly.

It is unnecessary to wet the surfaces; a light, evenly distributed film is sufficient

<u>Special case for wasps and hornets:</u> spray the nest in concentric circles from the periphery to the center. As a general guideline, approximately 1 L is needed to treat a medium-sized nest.

The quality of the treatment is as important as the quality of the product. Using a professional sprayer with an anti-drip lance is highly recommended.

<u>LODI advice:</u> rinse the sprayer thoroughly after use with clear water.

Storage and disposal

Keep out of reach of children and pets. Remove personnel, animals, aquariums, and food from the area to be treated. Be careful with electronic equipment and sensitive surfaces (e.g., varnish). Test in a hidden corner.
