

# PHOBI FUMISTOP

READY TO USE SMOKE GENERATOR

### PROFESSIONAL USE

#### Composition

Permethrin (CAS Number 52645-53-1): 13.5 g

#### Indications

**Mode of action:** disturbs the nervous impulse of the insect.

**PHOBI FUMISTOP** is an insecticidal smoke generator effective by contact on a number flying and crawling insects :

Flies (*Musca domestica*), Calliforidi (*Calliphora vomitoria*), Mosquitoes (*Culex pipiens*), Cockroaches (*Blattella germanica*, *Blatta orientalis*, *Periplaneta americana*), Cat fleas (*Ctenocephalides felis*), Mediterranean flour moth (*Ephestia kuehniella*), Indian meal moth (*Plodia interpunctella*), Cigarette beetle (*Lasioderma serricorne*)

#### Strengths

- Broad spectrum action on flying and crawling insects.
- 100% guaranteed mortality.
- Ideal for the treatment of private homes, cellars, garages, attics, crawl spaces...
- Easy to set up volume treatment.

#### Instructions for use

**Indoor use only.** The product is intended for indoor use only and should be strictly applied in areas not cleaned with water: as domestic areas (private houses), garages, cellars, attics, crawl spaces, commercial warehouses in industrial and commercial areas, service premises electricity, containers, trucks, or trains that carry cereals.

Hermetically close the treated area, close the windows and doors for at least 4 hours for cockroaches and flies, and up to 24 hours for other species. Use the required number of smoke according to the target and the volume to be treated.

Place them on a fire proof surfaces, but never in a closed space such as a bucket, After treatment, the area has to be thoroughly ventilated opening doors and windows.

**Flies / mosquitoes :** 30 g for 950 m<sup>3</sup>, 60 g for 1900 m<sup>3</sup>

**Crawling insects :** 30 g for 60 m<sup>3</sup>, 60 g for 120m<sup>3</sup>

**Cat fleas :** 30 g for 240 m<sup>3</sup>, 60 g for 480 m<sup>3</sup>

**Store food insects :** 30 g for 240 m<sup>3</sup>, 60 g for 480 m<sup>3</sup>

Consider the life cycle and characteristics of insects targets to adapt treatments. In particular, target the most susceptible developmental stage of the target organism.



#### Packaging

- 30 g smoke
- 60 g smoke

#### Storage and disposal

Do not store the product near a heat source. The product must not be stored at temperatures above 40°C.

Shelf life: 2 years.

Do not dispose of the biocide product in drains (sinks, toilets...), gutters, waterways, open fields, or any other outdoor environment. Packaging and product must be disposed of as hazardous waste under the full responsibility of the holder of such waste.
