PROFESSIONAL USE

Composition

Cypermethrin (CAS Number 52315-07-8): 100 g/L *Chrysanthemum cinerariaefolium* extract from open and mature flowers of *Tanacetum cinerariifolium* obtained with supercritical carbon dioxide (**Pyrethrum**) (CAS Number 89997-63-7): 0,1 g/L

Strengths

- Long-lasting action.
- Chock effect.
- Broad spectrum action.
- **Low odor:** formulated in aqueous emulsion, this type of preparation has the advantage of being low in odor.

Indications

Mode of Action:

PHOBI CYPERBIO 100 EW acts through contact and ingestion on insects. Cypermethrin, a molecule from the pyrethroid family, disrupts the transmission of nerve impulses along axons by prolonging the opening of sodium channels in the walls of nerve cells. Cypermethrin provides **PHOBI CYPERBIO 100 EW** with a knockdown effect combined with strong long-lasting action.

Spectrum of Action:

PHOBI CYPERBIO 100 EW acts on a broad spectrum of crawling and flying insects, such as cockroaches, ants, fleas, wasps, flies, mosquitoes, as well as arachnids (spiders and mites).

PHOBI CYPERBIO 100 EW is particularly suitable for sites where clients demand low-odor products.

Instructions for use

- Shake the bottle before diluting the product.
- Mix 250 ml of **PHOBI CYPERBIO 100 EW** with 5 liters of water in the sprayer.
- Mix thoroughly to obtain a homogeneous solution.
- Apply the dilution using a sprayer at a rate of 5 L per 100 m².

Ventilate during the treatment and thoroughly air out the area (indicatively: 30 minutes to 2 hours depending on ventilation level) before reoccupying the treated space.

Repeat the treatment in case of re-infestation.

Storage and disposal
